Allocation across Market Cap: Since portfolio is concentrated, focus is more on stock selection than on market cap allocation.

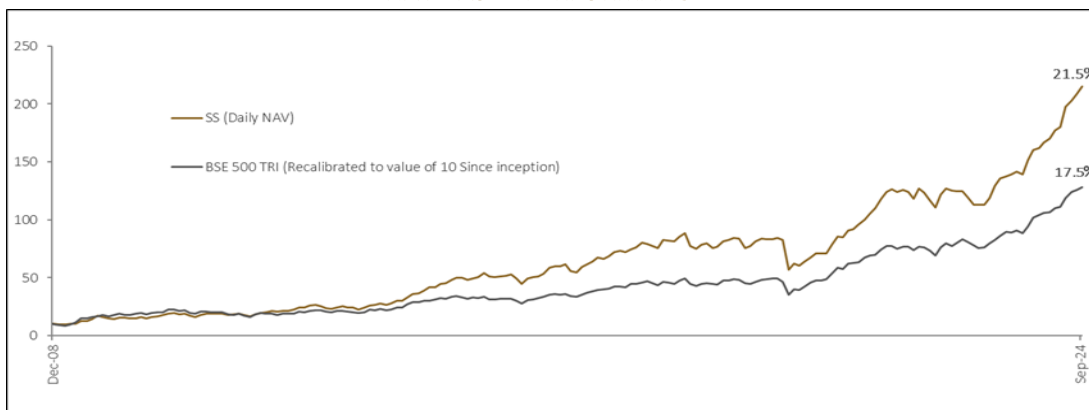

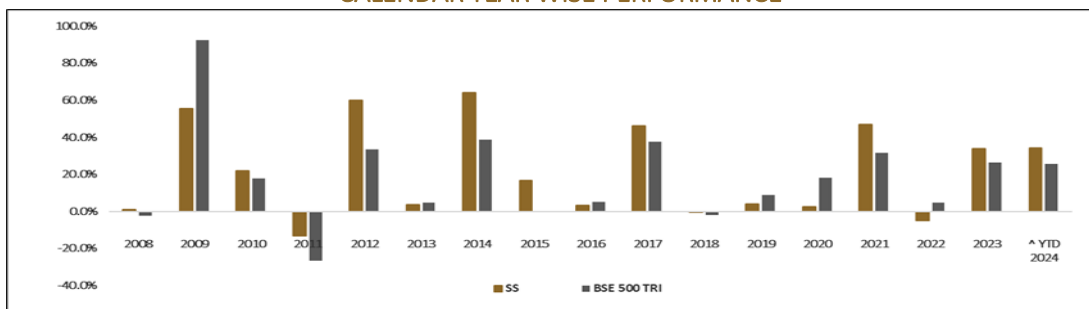
